GENERAL POLICIES AND GUIDELINES OF THE DISTRIBUTION COMMITTEE

All grants are for the benefit of citizens of Pitt County through qualified charities.

Grants will be made at regularly scheduled quarterly meetings of the DISTRIBUTION COMMITTEE, or at called meetings. Any member of the DISTRIBUTION COMMITTEE may call a meeting. A simple majority of voting member shall constitute a quorum.

It is basically the intent and desire of the DISTRIBUTION COMMITTEE that grants shall be to initiate, expand, or improve direct services to the people of Pitt County for acquisition of fixed assets or capital improvements. Grants, except in special circumstances, should not be used to fund the ongoing operating budget of the organization.

The governing board of the applicant organization must approve the application prior to its submission to the DISTRIBUTION COMMITTEE.

Except in unusual cases, grants are approved for one year. Support for a particular purpose is normally limited to three years.
