

# Northwest Elementary School Title I Parent Engagement Policy

Section 1118 of the ESSA Waiver formally replacing ESEA requires the engagement of parents of participating children in the planning and implementation of District and School Title I projects. Such programs, activities, and procedures shall be planned and implemented with meaningful consultation with parents of participating children.

## To involve parents in the policy process we will:

- Encourage all parents to attend the Title I Curriculum Night, held at the beginning of the year, to learn about Example School's participation in Title I, the requirements of the Title I program, and your rights as parents to be involved.
- Hold Title I Parent Engagement meetings at different times and on different days, and may provide transportation, child care, or home visits to accommodate the scheduling needs of our parents.
- Involve parents in an organized, ongoing, and timely way in the planning, review, and improvement of Northwest Elementary School's Title I programs, including the planning, review, and improvement of the school parental Engagement policy and the joint development of the schoolwide program plan (if applicable).

- Upon request, provide parents with opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to suggestions as soon as possible.
- If Northwest Elementary School's Schoolwide program plan (if applicable) is not satisfactory to the parents, we are required to submit any parent comments on the plan to Pitt County Schools Federal Programs Office.

## To share responsibilities for high student academic achievement we will:

- Develop with parents, a school-parent compact that outlines how parents, school staff, and students will share responsibility for improved student academic achievement.
- Help parents create a supportive and effective learning environment at home by providing information on the importance of attendance, homework completion and the positive use of extracurricular time; limiting time spent watching television and playing video games; and volunteering in their child's classroom and participating in decisions relating to the education of their children.
- Address the importance of communication between teachers and parents through parent-teacher conferences, progress reports, and provide reasonable access to staff, opportunities to volunteer and participate in their child's class, and observe classroom activities.

#### To build capacity for Engagement we will:

- Ensure effective engagement of parents and support partnerships among Northwest Elementary School, our parents, and our community to improve student academic achievement.
- Provide assistance to parents in understanding topics such as the State's academic content standards, the State's student academic standards, State and Local assessments, the requirements of Title I, and how to monitor your child's progress and work with educators to improve the achievement of your children.
- Provide parents with materials and training, such as literacy materials and technology training, to help them work with their children to improve their achievement, and to foster parental engagement.
- Educate teachers and school staff about the value of the contributions of parents; how to reach out to, communicate with, and work with parents as equal partners; implement and coordinate parent programs; and build ties between the parents, the school, and the community.

- Provide information related to Pitt County Schools, Example School, plans, meeting notices, report cards, and other accountable information in a format, and to the extent practicable, in a language that parents understand.

Northwest Elementary School Title I Program Description: The Title I program at NWE encourages authentic and committed parent involvement in the education of their children. During the 2021-2022 school year, we will offer 5 Title I events at different times during the day: some during evening hours and some during school hours. Each event allows for family involvement and is designed to help parents learn more about how they can support their children's success in school - academically, socially and emotionally. Having learned that many parents and families are able to engage virtually when they may not be able to engage in person, we will offer as many of these parent involvement opportunities in a hybrid manner - utilizing in-person events with virtual options or hosting entirely virtual family events when that is the safest option.

Our Title I budget will be utilized to reduce class sizes, increase instructional support personnel and to support family involvement events and programs.
