# 1) Start of Meeting

- B) Benjie Forrest led the Board members in the Pledge of Allegiance followed by a Moment of Silence and ended with a prayer.

#### 2) Routine Business

### A) Adjustments to the Agenda

Caroline Doherty made a motion to approve the Agenda as presented with a second by Worth Forbes. The motion to approve the Agenda as presented passed unanimously.

#### 4. New Business:

1) Ron Butler, Director of Community Schools, and Alice Keene, Pitt County Special Projects Coordinator, shared information involving a Joint Resolution between Pitt County Government and Pitt County Schools to restructure the Pitt County Community Schools and Recreation Advisory Council. Ms. Keene requested approval from the Board members. After some discussion, Mary Blount Williams made a motion to approve the Joint Resolution between Pitt County Government and Pitt County Schools to restructure the Pitt County Community Schools and Recreation Advisory Council, with a second from Melinda Fagundus. The motion to approve the Joint Resolution between Pitt County Government and Pitt County Schools passed 8-1 with Chair Smith, Vice Chair Flanagan, Amy Cole, Benjie Forrest, Melinda Fagundus, Tracy Everette-Lenz, Worth Forbes, and Mary Blount Williams voting in favor and Caroline Doherty voting against.

- 2) Beth Ann Trueblood, Director of CTE, shared two programs in place that will benefit Pitt County School students with hands-on work experience, Tradesformers and Grow Local. Tradesformers is a pre-apprenticeship program designed to connect high school seniors with industry trades in Pitt County. The 2019-20 school year will be the first for the program, and three local businesses will be involved. Grow Local is led by the Greenville-Pitt County Chamber of Commerce and Pitt County Development Commission, in which Pitt County businesses open their doors to host local middle and high school students, providing them with an experience to introduce, involve, inspire and invest in students and young adult lives. Much discussion occurred between Ms. Trueblood and the Board members.
- 3) Matt Johnson, Assistant Superintendent of Operations, shared the following information with the Board members.
  - 26 School Resource Officers have been assigned to Pitt County Schools, allowing all schools to have coverage
  - Confidential Security Assessment Report created in January 2019 by R.R.A. Risk Management Services
  - An update of the \$116,000 security grant PCS received to purchase school security equipment

Some discussion occurred between Mr. Johnson and the Board members.
