A) Chair Smith called the Board Work Session to order at 12:00 P.M.

## B) Closed Session

#### D) Finance

## 1. 2018-2019 Financial Audit Contract

Debra Baggett, Chief Financial Officer, discussed the 2018-2019 financial audit contract with the Board members. Ms. Baggett stated the contract would be with Carr, Riggs, and Ingram, LLC at a cost of \$54,350.00, which includes financial statements. She stated this is a 4 percent increase from last year. Ms. Baggett also shared the option of a 3-year contract which would lock in a 2.5 percent increase per year. The 3-year cost is as follows:

- 2018-2019- Audit \$46,350/ Financial Statements \$7000/ Other Services \$1000/ Total \$54,350
- 2019-2020 Audit \$47,700/ Financial Statements \$7000/ Other Services \$1000/ Total \$55,700
- 2020-2021 Audit \$49,100/ Financial Statements \$7000/ Other Services \$1000/ Total \$57,100

After some discussion, the Board members decided to the 3-year contract option with the plan to bid out the contract once the three years are complete. Ms. Baggett requested the 2018-2019, 2019-2020, and 2020-2021 Financial Audit Contracts be listed on the June 3, 2019, Board Agenda.

Consensus of the Board members was to allow the 2018-2019, 2019-2020, and 2020-2021 Financial Audit Contracts be placed on the June 3, 2019, Board meeting Consent Agenda.

# 2. 2019-2020 Interim Budget Resolution

Ms. Baggett shared the 2019-2020 Interim Budget Resolution with the Board members. Ms. Baggett explained that North Carolina General Statute 115C-434 that supported the resolution and requested the 2019-2020 Interim Budget Resolution be listed on the June 3, 2019, Board Agenda. After little discussion, consensus of the Board members was to allow the 2019-2020 Interim Budget Resolution be placed on the June 3, 2019, Board meeting Consent Agenda.

DEEL Building Contract to Proceed

Matt Johnson, Assistant Superintendent of Operations, discussed bids received to complete the DEEL offices, located on Allen Road, with the Board members. Mr. Johnson shared the low bid with alternates of \$987,600 from Farrior and Sons and a

Much discussion occurred between Mr. Bowers and the Board members.

College and Career Promise and AP Courses

Next, Mary Carter, Director of Secondary Education, discussed College and Career Promise and AP Courses with the Board members. Ms. Carter's presentation included the following.

- 2019 graduating class is the 1st class that NC SBE Policy GRAD-009 affects
- Advanced Placement Career and College Promise Enrollments
- Number of students enrolled in college immediately following high school
- PCS & PCC Technical Academy and course offerings
- Additional CCP opportunities

Excerpts from NC SBE Policy GRAD-009 Ms. Carter shared with the Board members are listed below:

3.1.2. ... Effective with the freshman class of 2015-16, the weighting for Honors courses shall be one-half (.5) of a quality point.

# 3.1.3. Advanced Courses, Advanced Placement/International

Baccalaureate/Cambridge International Examination (AP/IB/CIE) courses - Course content, pace and academic rigor are considered college-level as determined by NC's Institutions of Higher Education and are designed and overseen by the College Board (AP), .... Effective with the freshman class of 2015-16, the weight for AP/IB/CIE courses shall be one (1) quality point.

3.1.4. College courses ("dual enrollment") .... College courses, which may be delivered by a community college, public university or private college or university, provide credit toward a high school diploma and may satisfy a graduation requirement or provide an elective course credit. The state weighting system adds the equivalent of one (1) quality point to the grade earned in community college courses included on the most recent Comprehensive Articulation Agreement Transfer List, and for courses taught at four-year universities and colleges.

To determine the value added quality point added to any CTE course at the college level, you must refer to the Master Course Code list in PowerSchool provided by DPI. These courses vary from no value added quality point, to .5, to 1.

Much discussion occurred between Ms. Carter and the Board members concerning the timing of pulling grades to determine school based honors. At the request of the Chair Smith and several Board members, Dr. Lenker, Dr. Lassiter, Ms. Carter, and Mr. Bowers will meet to discuss the current administrative procedure and options to create equality for all students. Once options are discussed, a meeting with the Board members will be scheduled to provide suggestions for a more equitable solution.
