## 1. Start of Meeting

A. Chair Melinda Fagundus called the Board of Education meeting to order at 6:30 pm, and due to a member electronically present, took roll call. Tracy Everette-Lenz, Amy Cole, James Tripp, Don Rhodes, Anna Barrett Smith, Caroline Doherty, and Benjie Forrest were present, while Worth Forbes was present via Zoom.

B. James Tripp led the Board members in the Pledge of Allegiance and Moment of Silence.

#### 2. Routine Business

A. Adjustments to the Agenda

Chair Fagundus asked if there were any adjustments to the agenda as presented. Hearing none, she asked for a motion to approve the agenda. ## A. Physical Inventory Project

Chair Fagundus recognized Debra Baggett, Chief Finance Officer, and Dr. Lenker, Superintendent, who presented information to the board regarding a proposed contract with Hayes Software Systems. Hayes will perform a physical inventory of the Board's technology assets. The full price of the contract is either \$178,325 if incoming assets are received bar coded or \$181,025.00 if not. roll call vote, the motion to contract with Hayes Software Systems passed unanimously.

B. Resolution and Related Documents to Secure Local Obligation Bond C. Funding for A.G. Cox Renovation

Chair Fagundus recognized Emma Hodson, In-House Counsel, who presented information related to the renovation and expansion of A.G. Cox Middle School. Ms. Hodson shared that the County Commissioners must pledge A.G. Cox Middle School as collateral to secure the funding necessary to complete the project. Ms. Hodson also shared that the lender providing the funding has asked that the Board approve a resolution conveying the A.G. Cox property to the County Commissioners, a Construction & Acquisition Agreement, and a Lease Agreement. Benjie Forest made a motion to approve the Resolution, Construction & Acquisition Agreement, and Lease Agreement, with a second from James Tripp. After a roll call vote, the motion to approve the documents to secure the local obligation bond passed unanimously.

### **COVID** Update

Chair Fagundus recognized Dr. Ethan Lenker, PCS Superintendent, who shared COVID-19 updates for the district with the Board. Dr. Lenker shared the following information:

Dr. Lenker discussed the possibility, that if the State allows districts to start school early, PCS may update the start of school to August 16, 2021. Dr. Lenker also thanked Dr. John Silvernail, Pitt County Health Director, and Van Smith, Executive Vice President at Vidant, for their collaboration with Pitt County Schools to vaccinate over 1300 employees last week.

Next, Dr. Lenker shared that earlier in the day senior staff hosted a visit from DPI leaders, which included a visit to the Technical Academy at Pitt Community College and the Early College at ECU. Dr. Lenker shared that the State Superintendent chose PCS due to it being one of the largest school districts to hold in-school instruction since day one of the pandemic. Dr. Lenker stated that the visit was a testament to our teachers, community, and support from our Board and the senior leadership staff.
