The Board Work Session was held at the Kathy Taft Center and called to order at 12:00 p.m. by Chair Betsy Flanagan.

Student Services Updates

Jim Hooker and Pastor Rodney Coles presented a community feeding our children presentation with the Board members. The presentation included the following:

Finance Updates

1. 2020-2021 Budget Amendment #1

Debra Baggett, Chief Finance Officer, discussed budget amendment #1 with the Board members. Some of the discussion included the following.

Dr. Kristi Rhone Assistant Superintendent of HR, and Lori Collins, Educator Support Coordinator, shared the following updates with the Board members.

- The Need to Continue Virtual Mondays will be revisited in February
