Don't forget that the following artifacts are required for ALL Title I events:

- 1) Parent Invitations (In all languages represented in your school)
- 2) Agenda from Meeting
- 3) A copy of your presentation or handouts/materials shared with parents that are "educating them".
- 4) Parent Sign-In Sheets

****Remember that you MUST have 5 non-PCS employees present at an event for it to qualify for reimbursement. The maximum reimbursement is \$4.50 per person.**
