Employee Reimbursement Forms:

The revised employee reimbursement forms have been posted on the PCS Finance website. For any travel that occurred after September 1, 2024 this form MUST be used. You will find the page for that form linked <u>here</u>. Please note the following change:

- Meal receipts are no longer required
- This form MUST be typed, we will NOT accept handwritten forms

The following items are still required to be attached:

- Copy of the approved Estimate of Travel Form
- Copy of the Conference Agenda
- Mapquest or Google Map Printout to reimburse mileage
- Receipts for baggage, parking, rideshare, etc



Contract reminders:

- Adhere to the following rates of pay:
 - Certified: \$25/hour
 - Classified: \$15/hour
- Contract must state that they will follow the PCS Student Calendar

Contract Reminders Continued:

- Must have a "not to exceed" amount
- Must list the # of days or "not to exceed # of hours per week"
- Must include the Budget Code

All contracts must be signed by the Principal, the Federal Programs Director, the Employee, and Human Resources BEFORE they begin working in your building!

Funding Reminders:

- We do allow you to use funds to pay for people (teachers, teacher assistants, remediation teachers) prior to the new plan being approved.
- We do allow you to use Parent Engagement Funds prior to the new plan being approved.
- We do NOT allow you to purchase items, software, materials, etc. until after the new plan has been approved. This typically occurs late October or early November.
- If you submit a Purchase Order that is not for Parent Engagement or People, it will be held until AFTER the plan has been approved.
- Do NOT order items not related to parent engagement and expect to be reimbursed. You MUST wait until the new plan is approved.
- You MUST submit the Request to Use Federal Funds Form BEFORE you spend any funds! It can be emailed to me and I typically get this form back to you within 24 hours.
