# PITT COUNTY SCHOOLS SUMMER ENRICHMENT RULES AND REGULATIONS 2025

### Pitt County Schools Summer Enrichment Program does not condone and will not permit:

- 1. Corporal punishment
- 2. Ridiculing, threatening, using an inappropriately loud voice
- 3. Leaving children unsupervised
- 4. Use of profanity

# A child's behavior is expected to be consistent with the following:

- 1. Use of appropriate language at all times.
- 2. Cooperate with staff and follow rules/directions.
- 3. Respect other children and staff, equipment and facilities, and yourself.
- 4. Remain in designated areas with the program staff; running away from staff out of designated areas without permission is not acceptable, and may result in termination from the program.
- 5. Non-disruptive/aggressive behaviors during activities or group assignments.
- 6. Unauthorized use of electronic or communication devices.

# Behaviors, which may result in immediate dismissal, include but are not limited to:

- 1. Any action that could threaten or pose a direct threat to the physical/emotional safety of the child, other children, or staff. Prohibited conduct may include, but is not limited to, abusive jokes, insults, slurs, threats, name-calling, bullying, or intimidation.
- 2. Fighting/Simple Assault/Spitting
- 3. Possession of a weapon of any kind
- 4. Damage, or injury to personal or real property
- 5. Sexual misconduct
- Possession of or use of alcohol or controlled substance unless under the prescription of a doctor. Leaving designated areas without permission. Inappropriate behavior on the bus such as; opening the emergency door, hanging out the window, climbing over or under seats, etc.
- 7. Any child, who exhibits behavior that threatens his or her well-being, or the well-being of others, is subject to dismissal from the Summer Enrichment Program.
- 8. Masks will be worn by all during the program (in accordance with the latest guidelines).
- 9. Any child who triggers the fire alarm will be suspended indefinitely and the parents may be fined.

#### **Parent Code of Conduct**

Upon presentation of identification, parents/legal guardians have the right to enter and visit the facility which their child(ren) is/are receiving care.

The law authorizes the person in charge of the afterschool program to deny access to the parent/legal guardian under the following circumstances:

The parent/legal quardian is behaving in a way that poses a risk to the children in the facility.

The parent/legal guardian has provided the afterschool program with an updated court document stating custodial rights, protection orders, and/or visitation restrictions.

Under no circumstances should a parent/legal guardian approach another child other than their own.

While in the facility parents are expected to act appropriately by speaking in an appropriate tone and using appropriate language at all times.

Any parent who does not behave in this manner will be asked to leave the facility. Any inappropriate behavior by a parent including verbal abuse of a child, or staff member and/or confrontation with a center staff member will not be tolerated.

### **Field Trips**

Summer Enrichment staff is responsible for your student during field trips.

On long field trips, students must ride the activity bus with the Summer Enrichment group. Students may ride back with parents/guardians as long as he/she is properly signed out.

Volunteers are not normally needed for field trips. If volunteers are needed, the Summer Enrichment staff will let parents know, and will have you sign up

# **Parent Grievance Procedure**

If you have a grievance regarding the Afterschool Program, immediately set up an appropriate time to discuss the issues or concerns with the program director. We want to address any questions or concerns you or your child might have regarding the program. Please encourage your child to speak directly to any staff member in the program about issues they are uncomfortable with, so that we can address them in a timely manner.

Your signature represents that you fully understand the rules for this program. If your child or children do not adhere to these rules they may be suspended or dismissed from our program.
