Action Step 2: Implementation of 9-12 district supported learning initiatives:

- Development of Faculty Senate: Form a PLC team consisting of department heads from each high school to study achievement data and design district solutions

Action Step 3: Implementation of the MTSS (Multi-Tier System of Support):

- Begin training of staff and development of processes
- Continue and expand the implementation of PBIS (Positive Behavior Intervention and Support)
- Identify a universal screener for use in RTI (Response to Intervention)
